

## Communication and People Skills at Executive Level (SE1) Examination July 2017

The Communication and People Skills examination of the Executive Level (SE1) will be held on 30<sup>th</sup> July 2017 in Colombo, Kandy, Galle, Kurunegala and Jaffna. This Examination will be conducted in two parts. <u>Part One consists of Reading, Writing and Listening and Part Two consists of Speaking.</u> Two separate admission cards will be issued for Part One and Two. Date/time of the Speaking test will be notified to you in due course. It is compulsory to complete all four sections (skills) of the examination.

- All students who apply for the SE1 final exam for the <u>first time</u> should have fulfilled the <u>80%</u>

  <u>Attendance</u> requirement of its course by the time they apply for the SE1 exam. It's compulsory to attach your <u>Original Attendance Certificate</u> along with your SE1 exam application. Please contact the particular Teaching College where you attended the SE1 course to collect your attendance certificate. Students who have been exempted from the course are requested to attach the confirmation of results along with their exam application form.
- The Examination fee for SE1 Examination is **Rs. 2,500/=** The fee should be paid in cash to any branch of Bank of Ceylon to the credit of the Institute of Chartered Accountants of Sri Lanka, Collection Account No. 2323142 Bank of Ceylon, Torrington Square Branch. Pay—in-Vouchers in triplicate are enclosed herewith for this purpose. Please attach the copy of CA Sri Lanka with your application.
