Prize Winner Criteria – CA Sri Lanka Curriculum 2025

The Institute of Chartered Accountants of Sri Lanka (CA Sri Lanka) is pleased to present the Prize Winner Criteria applicable to all examination levels under the new Curriculum 2025.

1. Business, Corporate & Strategic Levels

Subject Prizes

- Awarded only to first-attempt candidates.
- Granted to the highest scorer in each subject, with a minimum of 70% marks.
- If multiple candidates obtain the same highest marks, the prize will be awarded jointly.

Order of Merit

- Applicable only to first-attempt candidates.
- Candidates must achieve:
 - A minimum average of 75% (total marks ≥ 300)
 - A minimum of 70% in each paper
- The top three candidates meeting the above criteria will receive Merit Prizes.
- In the event of equal marks, the prize will be awarded jointly.
- Candidates must have successfully passed the examination.

2. Capstone Level (B-Cap, C-Cap & S-Cap)

Subject Prize

- Awarded only to first-attempt candidates.
- Granted to the highest scorer, with a minimum of 70 marks.
- If multiple candidates obtain the same marks, the prize will be awarded jointly.

3. Benefits for Prize Winners

Subject Prize Winners (Business & Corporate Levels)

- Free study pack for the next level (same pillar subject)
- Exemption from the examination fee for the same subject
- Benefits are not transferable to future levels

Merit Prize Winners (Business & Corporate Levels)

- Free study packs for all subjects at the next level (same pillars)
- Exemption from examination fees for those subjects
- Benefits are not transferable to future levels

Important Conditions

- Fee exemptions are valid only if the next attempt is taken within the next two immediate examination sittings.
