

6. Visa requirements

With regard to VISA processing for entering Sri Lanka, the following three options are available:

- Visa confirmation through ETA (Electronic Travel Authorisation system. Please visit http://www.eta.gov.lk)
 - Step 1: Fill the details on the web link
 - Step 2: Online payments through credit card (Approximately 30 USD)
 - Step 3: Confirmation and the reference number will appear on the screen (Take a print

out of the confirmation).

- Step 4: Submit the reference number and the confirmation printout at the airport.
- 2. Visa on Arrival to Sri Lanka
- The delegate can come to Sri Lanka and get On Arrival VISA at the Airport Sri Lanka Immigration & Emigration Department Counter (Payment of Approximately 30 USD will be required)
- 3. Manual Visa processing through the Sri Lankan Embassy at the respective countries. We recommend the first option, as it is convenient, straight forward and well accepted.
