NB:

- The above exemptions are based on the criteria that the candidate has duly completed all the requirements prescribed under each corresponding Higher National Diploma. In the event a candidate is yet to fulfill a particular requirement/s he/she shall follow the corresponding course/s as decided by the School of Accounting and Business.
- The basic entry requirement is successful completion of the GCE Advanced Level examination (Local/London).
- If the candidate has completed the courses marked with an asterisk (*) as a part of other academic/professional qualifications (such as MBA/SLIM/CIM etc.), he/she may be exempted from such courses subject to the approval of School of Accounting and Business (SAB) and the payment of exemption fee of Rs 5000/= per each additional course exempted.
- The maximum number of credit values that can be completed during a semester is limited to 26.

After successful completion of the BSc (Applied Accounting) General degree, the students could complete the BSc (Applied Accounting) Special degree by completing the following additional courses marked with a (v).
