Dear Student,

DEADLINE FOR ISSUING APPLICATIONS / CERTIFICATES UNDER CURRICULUM 2015

The Council of the Institute of Chartered Accountants of Sri Lanka (CA Sri Lanka) has decided to discontinue the susance of the Certified Busiess Accountant (CA) / Certified Business Accountant (CSIA) certificates under Carriculum 2015 with effect from 30th June 2020 due to the Introduction of the curriculum 2020 with effect from 1th January 2020.

Accordingly, CA Sri Lanka will only issue the certificates prescribed under the curriculum 2020 subsequent to the closing date of 30th June 2020 after completion of the below requirements under curriculum 2020:

Qualification	Requirements to satisfy as per the qualification awarding structure under curriculum 2020
Certified Business Accountant (CBA)	Business Level Professional Knowledge Course Units Business Level Professional Experience Professional Vales, Ethics and Attitude Course Unit Viva voce & presentation Business Level Professional Skills Units
Certified Corporate Accountant (CCA)	Corporate Level Professional Knowledge Course Units Corporate Level Professional Experience Professional Values, Ethics and Artitude Course Unit Viva voce & presentation Case study report Corporate Level Professional Skills Units

Therefore, students who have completed the relevant knowledge, practical training and skills modules as specified by CAS risk Lanka under carriericanta 2015; and have not applied or obtained the eligibility for the CBA and CSBA certificates, are required to apply for the relevant certificate on or before 30th June 2020.

Accordingly, under the following circumstances, issuing certificates under curriculum 2015 will be discontinued after announcing the closing date as 30th June 2020:

a. Students who are eligible to apply for CBA and CSBA under curriculum 2015

Eligible students who are unable to apply before 30th June 2020, and apply on or after 30th June 2020, certificates will be issued under curriculum 2020 after completion of additional requirements under curriculum 2020 or based on exemptions, if available.

- b. Students who are unable to apply for certificates under curriculum 2015 before the closing date of 30th June 2020 due to non-completion of practical training
 - Students who have completed Executive level and the knowledge modules and skills modules (SEI & SE2) under curriculum 2015, CAB II examination under curriculum 2010 or Intermediate examination under curriculum 1990 to 2009

Students will be awarded CBA qualification under curriculum 2020 upon completion of required training. However, those students are required to complete additional requirements under curriculum 2020.

 Students who have completed Business level knowledge and skills modules (SB1 & SB2) under curriculum 2015, Strategic level 1 examination under curriculum 2010

Students will be awarded CCA qualification under curriculum 2020 upon completion of the required training. However, those students are required to complete additional requirements under curriculum 2020.

However, students will not be exempted from future carriculums of CA Sei Lanka and they have to complete the necessary examinations and other modules to obtain the relevant certificate.
