Password : First four digits of your NIC Number (example: 9012)

Please ensure your information is up-to-date or click the “Update Information” tab in the student menu of the website or “Student Profile” in the “CA Sri Lanka Student App”, and update the information prior to making your payment online. The email address in your profile should be updated in order to receive the digital receipt generated upon acknowledgement to your payment.

Alternatively, if you choose to do the renewal manually, make your payment to the nearest Bank of Ceylon branch and retain the institute copy with you.

The table below lists the normal and late payment amounts and the dates the payment should be made by:

|--------------|--------------------------------|-------------|
| Normal | 31 st December 2020 | LKR 2200.00 |
| Late | 31 st January 2021 | LKR 3300.00 |
